

# Advantage Membership Terms and Conditions – 2024

## Advantage Program

1. All new members must pay an initial joiners fee of \$49+tax.
2. Membership dues for the program are \$8.50+tax each month throughout the entire 12-month calendar. Initial monthly fee is charged upon registration and is not pro-rated, covering the remainder of the month it was purchased. Monthly dues will then be automatically charged on the 1<sup>st</sup> day of each month to the credit card/bank account on file.
3. Monthly membership dues cover unlimited greens fees on weekdays, weekends and holidays. Advantage members must pay the respective riding cart fee for each 18/9 hole round of golf. These fees must be paid whether walking or riding. Paying the riding cart fee allows that member the option of taking a cart. Additional riders in this cart must also pay a fee. Playing additional rounds/holes require the member to check in with the pro shop and pay an additional 18/9 hole fee.
4. Advantage Members are not eligible for cart punch cards or season cart passes.
5. A 3% processing fee will be added to all credit card transactions. Members can switch their automatic withdrawal to ACH (direct bank payment) via their online account and avoid this additional fee.

## Policies

6. Advantage Membership dues do not cover participating in any shotgun-style league/tournament. Participation in these events requires separate payment of event fees unless otherwise noted by Clifton Hollow Golf Club.
7. All members must check in at the pro shop prior to each round using their member bar code card. All new members can pick up their bar code card by presenting a valid id at the pro shop desk. Lost member cards can be reissued with a valid id at the pro shop desk. Clifton Hollow Golf Club reserves the right to charge a fee for reissuing member cards.
8. Advantage members are allowed to book tee times no more than 7 days out. The member who books a tee time is financially responsible for all players of that reserved tee time. Clifton Hollow Golf Club reserves the right to charge members up to the designated rate for any missed tee times or for players who do not show for that tee time.

9. Clifton Hollow Golf Club reserves the right to change monthly dues and fees, as well as cancel or refuse membership to anyone for behavior unbecoming of a member, not limited to but including; missed tee times, showing up with fewer players than reserved, damage to course or property, verbal abuse of staff or other customers, not following staff directions, disruptive play, bringing on alcohol not purchased at Clifton Hollow Golf Club, sharing a membership with a non-member, and violating other course policies.
10. Any lapse in maintaining monthly membership dues will require the past member to join the wait list and the pay the initiation fee for reentry into the program.
11. Membership is specifically limited to the one person listed on the membership. Use of the membership by any other person will result in cancellation.
12. Memberships are non-transferrable.
13. Membership quantities are limited, with a waiting list for prospective members. Clifton Hollow Golf Club reserves the right to sell or not sell memberships at any given time.
14. Clifton Hollow Golf Club reserves the right to open and close the course at its discretion. Members and public are not allowed on the course during closures.

### **Cancellation of Membership**

15. Members may discontinue their membership with written cancellation notice by the end of the 25<sup>th</sup> of each month. All written cancellation notices must be submitted via the member cancellation form at [www.cliftonhollow.com/contact-us](http://www.cliftonhollow.com/contact-us). Final month dues are not pro-rated and memberships remain active until the end of the billed month. Failure to meet the cancellation deadline will result in billing for the following month.
16. If the automated monthly billing is rejected, the member will be notified of this by email and membership benefits will be suspended until payment is received. If by the last day of that month payment has not been received, the membership will be cancelled and the initial joining fee will be required to rejoin.
